

EVERYDAY LEGAL PROBLEMS AND THE COST OF JUSTICE IN CANADA AGE

OVERVIEW

INTRODUCTION

The national "Everyday Legal Problems and the Cost of Justice in Canada" survey was conducted with a random sample of 3,263 adults aged 18 years and older, of which 3,051 resided in households with landlines and 212 used cell phones only. The data presented in the following pages are based on the 3,051 land line calls. Weighted to the Canadian population, this represents an estimated 23,590,697 people from the ten provinces.¹

For this first national legal needs survey in ten years, respondents were asked questions aimed at measuring the frequency and ways in which they experience civil and family justice problems. Based on our survey results, it is estimated that within a 3-year period, 11.4 million adult Canadians (or 48.4%) will experience at least one everyday legal problem that they consider to be serious and difficult to resolve. Respondents to the Canadian Forum on Civil Justice's "Everyday Legal Problems and the Cost of Justice in Canada" survey were asked a series of demographic questions to help aid the analysis of the survey results. This report presents some of the key data from the "Everyday Legal Problems and the Cost of Justice in Canada" survey based on age. Data in this report are

organized into 4 age categories: 18 to 40, 41 to 54, 55 to 65 and 66 or older.

Of the 84 specific problem scenarios around which the *Everyday Legal Problems* national questionnaire was developed, problems were organized into the following 17 problem categories: Consumer, Debt, Employment, Neighbours, Discrimination, Family (Relationship Breakdown), Wills & Incapacity, Medical Treatment, Housing, Personal Injury, Treatment by Police, Disability Assistance, Threat of Legal Action, Social Assistance, Immigration, Family (Other) and Criminal Charges (in the context of experiences of civil justice problems).² The data reflecting respondent experiences of each of these problem types have been reproduced in this report based on each of the 4 age categories.

The introductory pages of this report provide details on responses related to general attitudes towards the Canadian justice system. The remaining sections of this report present data related to: actions taken to address legal problems, satisfaction with the option(s) chosen and spending to address everyday legal problems.

Of the survey's 3,051 land line respondents, 78 respondents declined to provide their age. Of the 2,973 respondents, a total of 510 respondents indicated that they were 18 to 40, 873 indicated that they were 41 to 54, 792 indicated that they were 55 to 65 and 798 indicated that they were 66 or older. Weighted to the population, this represents an estimated 6,806,670 who are 18 to 40, 6,812,427 who are 41 to 54, 4,638,604 who are 55 to 65 and 4,865,277 who are 66 or older.³

GENERAL ATTITUDES

Adults in Canada experience approximately 35,745,000 separate everyday legal problems within any given three-year period⁴, of which a significant percent will be addressed with help from legal professionals and through the formal justice system. Notwithstanding, people in Canada have differing views on the fairness and accessibility of the Canadian justice system.

As part of the "Everyday Legal Problems and the Cost of Justice in Canada" survey, respondents were asked to indicate their level of agreement — strongly agree, somewhat agree, somewhat disagree or strongly disagree — with four statements about the justice system in Canada. The resulting data from these questions is presented in this General Attitudes section.

FAIRNESS

Respondents were asked to indicate to what extent they agree with the following statement:


The justice system in Canada is mostly fair

A majority of people in Canada over 18-75.4% —agree in some respect that the justice system in Canada is mostly fair.

Canadians 18 to 40 who somewhat agree that the justice system is mostly fair represent the largest group with a shared opinion on the fairness of the justice system—61.3% or approximately 4,169,139 people in Canada. This is followed by 58.8% of Canadians 55 to 65 who somewhat agree and 56.5% of Canadians 41 to 54 who somewhat agree that the justice system is mostly fair.

Canadians who are 66 or older represent the largest age group who disagree (somewhat or strongly) that the justice system in Canada is mostly fair. 23.8% share this view.

Respondents were asked to indicate to what extent they agree with the following statement:


The legal system works better for rich people than poor people

A majority of people in Canada over 18 - 74.2% – agree in some respect that personal wealth plays a part in interactions with the justice system in Canada.

Canadians 66 or older who strongly agree that the legal system works better for rich people than poor people represent the largest age group with a shared opinion in this category — 43.1% or approximately 2,095,452 Canadians. This is followed by 41.7% of Canadians 55 to 65 who strongly agree and 38.2% of Canadians 41 to 54 who strongly agree that the legal system works better for rich people than poor people.

Canadians who are 18 to 40 represent the largest age group who disagree (somewhat or strongly) that the legal system in Canada works better for rich people than poor people. 20.8% in this age group share this view.

Respondents were asked to indicate to what extent they agree with the following statement:


The legal rights guaranteed by the Canadian Charter of Rights and Freedoms make a difference when people have legal problems

A majority of Canadians over 18-74.8%- agree in some respect that the legal rights guaranteed by the Canadian Charter of Rights and Freedoms make a difference when people have legal problems.

Canadians 55 to 65 who somewhat agree that the legal rights guaranteed by the Canadian Charter of Rights and Freedoms make a difference when people have legal problems represent the largest age group with a shared opinion in this category—49.6% or approximately 2,302,770 Canadians. This is followed by 47.9% of Canadians 41 to 54 who somewhat agree and 46.5% of Canadians 18 to 40 who somewhat agree that the legal rights guaranteed by the Canadian Charter of Rights and Freedoms make a difference when people have legal problems.

Canadians who are 55 to 65 and 66 or older represent the largest age groups who disagree (somewhat or strongly) that the Canadian Charter of Rights and Freedoms make a difference when people have legal problems. 12.6% in each of these age groups share this view.

Respondents were asked to indicate to what extent they agree with the following statement:


Courts are an important way for ordinary people to protect their rights

A majority of Canadians over 18 – 81.8% – agree in some respect that the courts are an important way for ordinary people to protect their rights.

Canadians 41 to 54 who strongly agree that the courts are an important way for ordinary people to protect their rights represent the largest group with a shared opinion on the importance of the courts — 44.2% or approximately 3,008,087 Canadians. This is followed by 43.2% of Canadians 18 to 40 who somewhat agree and 41.4% of Canadians 18 to 40 who strongly agree that the courts are an important way for ordinary people to protect their rights.

Canadians who are 55 to 65 represent the largest percentage who disagree (somewhat or strongly) that the courts are an important way for ordinary people to protect their rights. 15.7% share this view.

1,416 respondents in total indicated that they experienced one or more civil or family justice problem(s) during the 3-year reference period of the "Everyday Legal Problems and Cost of Justice in Canada" survey. Of these respondents, 34 respondents refused to provide their age.


Weighted to the population, an estimated 11,420,890 adults in Canada experience at least one serious civil or family justice problem within a 3-year period.




EVERYDAY LEGAL PROBLEMS:

Canadians experience a range of civil and family justice problems. Consumer, debt, employment and neighbour problems are the most frequently occurring problem types, followed by family problems (related to relationship breakdown), problems related to wills and incapacity and medical treatment problems.





Percentage of People within Four Age Groups with One or More Debt Problems























Percentage of People within Four Age Groups with One or More Disability







Percentage of People within Four Age Groups who Experience 1 to 7 Problems






























